A Snapshot of Our Work at the **Community Health Center**

In Calendar Year 2015, the Community Health Center served 2,417 unduplicated individuals, and provided them with 8,450 visits to the Center (including both Christiansburg and Pearisburg sites). Over two-thirds of these patients were uninsured and low-income. Clearly, we are true to our mission to serve everyone, regardless of circumstances and ability to pay.



Health Center to be Renovated to **Better Serve our Patients**

I am happy to announce that this vear our Community Health Center building at 215 Roanoke Street in Christiansburg will receive a long-overdue capital renovation to help us better serve our growing patient base. Recently, we were fortunate to

receive an infrastructure improvement grant from the US Health Resources and Services Administration to pay for the addition of two patient exam rooms, a fifth dental operatory, and an updated and more accommodating entry and interior.

Our building was originally built as part of the Roberts Motel in the 1940's. It was once a bustling rest stop on Route 11, a scenic summer vacation byway that linked Northerners to the warm beaches of the South. It has since served as the Montgomery County Department of Social Services, the Free Clinic, and now the Community Health Center of the New River Valley. After many piecemeal facelifts, not much of the charm of the historic motel remains. We are quickly outgrowing our clinical spaces, patient flow is cumbersome, and wear and tear is evident throughout. Our community deserves better.

As design developments take place over the summer and fall, we will continue to serve all patients—med-



Giles County Receiving a **Big Dose of Oral Health Education**

As part of our exemplary G-SMILE Dental Program in Giles County, our dental staff members are busy working outside the walls of the Pearisburg Center—meeting with and providing oral health education to at-risk groups of all ages and walks of life. The goal is to provide age-appropriate oral health Catherine Mansdoerfer, DDS education and early interven-



tion, thereby improving oral health behaviors (for example, brushing and flossing, visiting the dentist, receiving sealants).

It is a challenge to impact deep-rooted community health behaviors, but we are definitely making a difference. Our modern new dental clinic at the Pearisburg Center is always at capacity. We're adding a new Dentist, New River Valley resident Dr. Catherine Mansdoerfer, who will begin serving patients in Pearisburg in July.

Call now to schedule an appointment for you or your child. Children's dental services are typically covered by insurance, including FAMIS and Medicaid, and adult dental services for the uninsured are discounted based on family income. 921-3502.

Patient Fees at the new Community **Health Center of the New River Valley**

All patients who earn 200% or less of the federal poverty level are offered a sliding fee based on family size and income. The fee for a medical visit ranges from \$20 - \$35.

Dental fees are deeply discounted for low-income patients. The typical fee for an exam and X-rays is \$35.00. Based on family size and total family income, dental treatment services are charged at 35% - 50% of the full fee.

Behavioral health visits for low-income patients range from \$10-\$25.

No patient is turned away due to an inability to pay. Our goal is to work with all patients on options available to them based on their individual circumstances.
